ALSHA MEETING MINUTES JANUARY 11, 2016

George next discussed the need for more funds to maintain the Charlotte County section of SW Kingsway Circle. It will take between \$3500 and \$4500 to bring the road to the point where the current deterioration is halted. This would include mowing, overlay and filling potholes. A motion was made by Bonnie for ALSHA to contribute \$300.00 to the road fund, seconded by Judy, passed unanimously.

Cleaning of the "Welcome to Lake Suzy" sign was discussed. Paying for the cleaning and painting is a problem.

Maureen will follow up USPS regarding the location of their storage pod at the gas station. Parking it on the other side would make it less conspicuous.

The County Commissioners will meet on January 26 to discuss usage of Shepherd's property on the corner of SW Kingsway and Kings Highway. The discussion will be should zoning be changed from residential to commercial. All of the ALSHA Reps present at today's meeting expressed an interest in having the "Miata Lady" return to the corner. Maureen will send a letter to the Commissioners expressing the opinion of ALSHA to that effect and that there should be close monitoring of the use of the corner.
